Subject: National Endowment for the Arts: **Challenge America Fast-Track** and **Art Works**

Date: January 15, 2014

**PLEASE NOTE** that the NEA allows UNM to submit only **ONE proposal**. This internal competition is for ALL proposals regardless of field or deadline. (For eg., you may be thinking of applying for a Dance grant with an NEA deadline of July 24; in order for you to compete in the UNM selection process you must participate in the pre-proposal competition described below, and **MUST SUBMIT YOUR MATERIALS TO OUR OFFICE BY NOON ON JANUARY 23. This is the ONLY competition that will be held for the NEA Art Works and the NEA Challenge America Fast-Track programs.**

Through the National Endowment for the Arts there is currently funding in two categories available: **Challenge America Fast-Track** and **Art Works**. The **Challenge America Fast-Track** category offers support primarily to small and mid-sized organizations for projects that extend the reach of the arts to underserved populations -- those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability. Grants are available for professional arts programming and for projects that emphasize the potential of the arts in community development. This category encourages and supports the following two outcomes:

- Engagement: Engaging the public with diverse and excellent art.
- Livability: The strengthening of communities through the arts.

The **Art Works** category refers to three things: the works of art themselves, the ways art works on audiences, and the fact that art is work for the artists and arts professionals who make up the field. To make "art work," the NEA has included the advancement of innovation as a core component of its mission as a way to ensure the vitality of the arts. Innovative projects are strongly encouraged. **Art Works** encourages and supports the following four outcomes:

- Creation: The creation of art that meets the highest standards of excellence,
- Engagement: Public engagement with diverse and excellent art,
- Learning: Lifelong learning in the arts, and
- Livability: The strengthening of communities through the arts.

Applicants will be asked to select the outcome that is most relevant to their project (you also will be able to select a secondary outcome).

All grants require a nonfederal match of at least 1 to 1. For example, if an organization receives a \$10,000 grant, the total eligible project costs must be at least \$20,000 and the organization must provide at least \$10,000 toward the project from nonfederal sources. **Challenge America Fast-Track** grants are for a fixed amount of \$10,000 and require a minimum \$10,000 match. **Art Works** grants generally will range from \$10,000 to \$100,000. Grants awarded under these guidelines generally may cover a period of support of up to two years. The two-year period is intended to allow an applicant sufficient time to plan, execute, and close out its project, not to repeat a one-year project for a second year. **Art Works (Artist Communities)** applications are due to NEA by February 20, 2014. **Art Works (Design)** applications are due to NEA by July 24, 2014. All other **Art Works** disciplines can be submitted for either deadline.

**This is a limited competition; each institution is limited to one proposal- for a Challenge America Fast-Track grant OR an Art Works grant. Please submit your 3-page preproposal (plus budget, CV, and cost sharing commitment plan) by NOON on Thursday, January 23, 2014 to [limited@unm.edu](mailto:limited@unm.edu) with the subject line indicating: NEA - your name.** *Please indicate Fast-Track or Art Works and which discipline your preproposal falls under.* Arrangements for meeting cost sharing requirements must be made in advance of submission of the pre-proposal. Additionally, the level of external/in-kind cost share contributions will be used as criteria for evaluation during review by the Limited Competitions Committee. No late submissions will be considered. The pre-proposal should address the major points that will be included in the proposal narrative, including: major project activities, intended project outcomes, intended beneficiaries and how the project will benefit the underserved community. The narrative should be accompanied by a **draft budget overview** (including cost share arrangements) and an **abbreviated PI CV**. The scoring will be weighted as follows: proposal narrative (70%), draft budget overview (15%), and abbreviated PI CV (15%).
