Subject: Limited Competitions: Con Alma Foundation of Santa Fe Small Grant, Northern New Mexico Health Grant Group (NNMHGG), and Technical Assistance Programs

**PLEASE NOTE: The sponsor has not officially released this call, so agency revisions to this call may be forthcoming. We will release updates to this limited competition if significant changes to the call will impact the limited competition selection process.**

The Con Alma Health Foundation of Santa Fe has announced that it will accept applications under its Small Grant, Northern New Mexico Health Grant Group (NNMHGG), and Technical Assistance Grant programs. Grant awards will be made only to qualified 501(c)(3) nonprofit organizations serving the residents of the state of New Mexico. The UNM Foundation (UNMF) will act as the fiscal agent for UNM grant applications.

Con Alma Health Foundation focuses broadly in the areas of health and human services with special emphasis on culturally diverse, rural and tribal communities. Priority consideration is given to proposals that demonstrate strong collaborative relationships, have multiple funding sources and a plan for sustainability and address systemic change rather than direct services.

No grants are made for direct services, lobbying, scholarships/fellowships, or for capital costs, including property, construction or renovations. Con Alma will not pay any indirect costs. Any project working with pueblo or tribal communities must submit a letter of support from the pueblo or tribe with the final proposal.

Con Alma will fund Small Grant and Northern New Mexico Health Grant Group proposals up to \$15,000. Technical Assistance grant funding ranges from \$2,500 to \$10,000. Grant term is January 1, 2019 to December 31, 2019. NNMHGG grants will only support activities in Los Alamos, Rio Arriba and Northern Santa Fe counties. The deadline for full proposals to the Con Alma Foundation is May 30, 2018.

**This is a limited competition; each institution is limited to one proposal. Please submit a maximum 1-page concept paper describing your program and its match with Con Alma's priorities; impact of the program; and the requested amount (no detailed budget is necessary at this time) by NOON on April 13, 2018 to [limited@unm.edu](mailto:limited@unm.edu) with the subject line indicating: Con Alma-your name.**

No late submissions will be considered. Please note: an alternative selection process will be used for this limited competition. The Limited Competition Management Team will collect the concept papers and provide them to the Con Alma Foundation who will conduct the review and decide who will be invited to submit full proposals. The submission of the full proposals will be done through the UNM Foundation.
