**Limited Comp. Instructions:** We will be conducting a two-step internal competition to ensure we have a review committee in place by the pre-proposal deadline. <u>You must complete both steps if you are interested in participating.</u>

Limited Comp. STEP 1: Required SOI Due Date: NOON on June 27, 2025 (for planning purposes)

Limited Comp. STEP 2: Pre-proposal Due Date: NOON on July 9, 2025

**STEP ONE:** Please submit your ~100-word **statement of interest** in UNM's **InfoReady Review portal**. This is a required step, and no late submissions will be considered. Note that SOIs will NOT be scored; we require them to assist us in forming a review committee.

**STEP TWO:** Please submit your 3-page pre-proposal, abbreviated budget, and CVs for key personnel via UNM's InfoReady Review portal. You will receive an email when the InfoReady competition has been converted from the SOI application to the pre-proposal application, but you may work on your documents outside the system before that. No late submissions will be considered.

The pre-proposal should address the following which will be used as the review criteria:

- 1. Justification of need: Explain how the project addresses an important modernization of research operation or support. How will successful completion of the project enable advancement in research operations of the facility or improve its efficiencies? Do the requested equipment and accessories adequately justify for the needs of the specific projects? How will the project benefit the shared-use facility, NIH-funded biomedical research, and/or the larger biomedical research enterprise at the applicant institution? How will the project modernize, optimize, or add new capabilities to the operations of the facility?
- 2. **Technical Expertise:** Does the institution have the technical expertise to make effective use of the requested equipment? Does the PD/PI have scientific or technical expertise in research fields supported by the facility?

- 3. **Operational Innovations and Benefits:** Does the equipment or project revolutionize or enable operational breakthrough of the shared facility? Does the project offer innovative technical solutions/technologies unafforded by current technologies within the facility?
- 4. **Administration:** Does the institution have the necessary resources to accommodate the instrument? How well will the available utilities and existing infrastructure support the requested equipment?.
- 5. **Institutional Commitment:** Are the plans for the management and maintenance of the requested equipment appropriate?

Please note, as per the solicitation: An individual application requesting more than one type of equipment (for example, a biosafety hood and a freezer) is not responsive to this NOFO and will not be reviewed.
