

## UNM as an HSI, MI, and MSI

A **Hispanic Serving Institution (HSI)** is defined by the [Higher Education Act of 1965 Section 502\(a\)\(5\)](#) as being an eligible institution, which means that it is an accredited institution of higher education that has an enrollment of needy students, and has an undergraduate full-time equivalent enrollment that is at least 25 percent Hispanic. Per this definition, the **University of New Mexico is an HSI university**. Per the [UNM Office of Institutional Analytics](#), as of the Fall 2020 semester, *49.92% of degree-seeking undergraduate students* at UNM are Hispanic.

A **Minority Institution (MI)** is an institution of higher education whose enrollment of a single minority or a combination of minorities exceeds 50 percent of the total enrollment. Per that definition, the **University of New Mexico is an MI**, as *52.67% of the total students* enrolled in Fall 2020 were from ethnic minority groups as defined by [20 U.S.C. § 1067k\(2\)](#).

A **Minority Serving Institution (MSI)** is defined by a number of funding agencies including the *National Science Foundation* as being an institute of higher education that has an undergraduate minority student population of 50% or more. As of the Fall 2020 semester, per the [UNM Office of Institutional Analytics](#), 58.46% of the undergraduate students are from ethnic minority groups making the **University of New Mexico an MSI**. UNM leads R1 universities in Native American/Native Hawaiian student enrollment with *5.92% of undergraduate students* identifying as such.

Per the [U.S. Department of Education Office of Postsecondary Education](#), UNM is one of sixteen Research I universities that are either eligible or potentially eligible based on minority grounds for Title III/Title V funding. Below is a breakdown of these universities including their percent of Hispanic undergraduate full-time equivalent students as of Fall 2019 which is when reports are shared with the Department of Education to compile their annual eligibility matrix.

Per their annual student enrollment disclosures, the University of New Mexico, University of Texas at El Paso, and Florida International University are the only R1 universities that are also Minority Institutions.
